# Hearing #1 Z-18-17 – Yori Adegunwa – IROY Gym – 1723 North Hills Drive, Norristown, PA 19401

The applicant is requesting a variance from §143-112 to permit an increase in the permitted amount of maximum impervious coverage of 64% to allow for the construction of a new indoor gym facility and required parking. The applicant had previously received a variance to permit development of the property with a maximum impervious coverage of 52% in decision Z-17-18, dated January 12, 2018.

The parcel ID # of subject property are 43-00-05155-00-4, 43-00-05155-00-7, and 43-00-05158-00-1. Subject property is located at 3444, 3446, and 3450 Germantown Pike, Lower Providence Township and is in the HC- Highway Commercial Zoning District.

#### Hearing #2 Z-19-01 – Dr. Matthew Berardi – 1313 DeKalb Street, Norristown, PA 19403

The applicant is requesting a variance from §143-72 to permit the construction of four parking spaces rather than the eight parking spaces required. The other four spaces will be held in reserve, rather than the two reserve spaces authorized by §143-72. The applicant also seeks a variance to permit the installation of one twenty square foot freestanding externally illuminated sign rather than the two square foot wall-mounted sign permitted for a home occupation under §143-141.1(C).

The parcel ID # of subject property is 43-00-10573-00-4. Subject property is located at 1501 Pawlings Road, Lower Providence Township and is in the R-2 – Residential District.
